Old Business

1. Mayor Update

Want to avoid getting Family Services involved. President Vigue and Mayor Trosky to contact Fetterhoffs. The goal is to see improvement on property unless there are safety concerns.

Mayor Trosky inquired about fundraising for parks. Verts stated there are certain processes and practices that need to be in place first. Brown and Forsythe will investigate.

2. Park Update

Will get back to Vice President Verts about Ireland Roofing. St. Barnabas to come back with specific number regarding their contribution to Valencia and EMS. Another meeting set for October. Vice President Verts will follow up. Need number to input into 2025 budget.

There is a camera on park that records. President Vigue asked that if anyone sees commercial vehicles in lot to let Council know.

Councilman Grey brought that someone drove into retention pond on New Year's Eve and St. Barnabas was to assess damage. Vice President Verts will follow up and make sure this took place.
