December 11, 2017 minutes from Valencia Borough Council.

ATTENDANCE: Pres. Brian Himmelstein, VP Shanon McKenna, Rob Vigue, Mayor Krystal Schultz.

Minutes were read. Krystal made motion to accept minutes with corrections, Rob seconded. Motion carried.

VISITORS:

Kaitlyn Boyland – Mars Library – introduced herself, advised she has 5 years experience. She noted the library circulated over \$15,000 in items over the year and offers 200 different programs.

Adams Police contract – Valencia reached out to Adams Twp. to approve contract. 2013 contract was drafted but never orchestrated. Valencia volunteered to increase to \$300/mo. Adams Twp. said it should have been \$400. They now want \$1000/mo. Adams agreed on a 1 year contract at \$700 then increase to \$1000 to \$1300/mo.

George St. drainage – Aiken explored the issue and found pipes were clogged. He found that the Gas Co. drilled thru the pipe for the gas line.
