Lot Line Revision Request

Mr. Himmelstein reviewed with commissioners a potential request for a lot line revision. The potential lots were 50 and 52 Allegheny Avenue. The revision would make the lot at 50 Allegheny Avenue into a non-conforming lot. Commissioners and Mr. Himmelstein agreed that unless a hardship could be proven, the request should be denied as it would violate Valencia Borough's Zoning Ordinance. The request will be submitted to Zoning Officer Chris Rearick for further review and input.

St. Barnabas PRD

Mr. Himmelstein has a site meeting with St. Barnabas tomorrow at 8:00 a.m. Mr. Himmelstein asked commissioners if St. Barnabas had contacted them regarding the well testing on their properties. Commissioner Verts and Commissioner Mullins stated that they had not yet been contacted by St. Barnabas.

Mr. Himmelstein reported that St. Barnabas still does not have their SFMP permit. Inspectors from engineering firm Scott Shoup's company are doing site inspections 2-3 times a week. Engineer Shoup will give monthly reports and let Council know of any issues that aren't resolvable.

Burning Ordinance

Commissioners discussed revisions that they want to make to the current burning ordinance. Adams Township sent out an advertisement for their soon to be adopted new ordinance. Commissioners would like to keep the new proposed Valencia Borough burning ordinance similar to that of Adams so that it would be easier to enforce. Commissioners discussed having a fireworks section in the burning ordinance as there has been issues with fireworks being set off in the middle of the night and during burning bans. Commissioner Verts will send out the burning ordinances from Pine Richland and Seven Fields for comparison.
